Directors' report for the year ended 31 December 2009

The Directors present their report and the audited Financial Statements for the year ended 31 December 2009. The Company has taken advantage of the small companies exemption available under section 415A of the Companies Act 2006 and have not prepared a business review.

Principal Activities

BG Group Employee Shares Trustees Limited (the "Company") was incorporated on 27 February 1996 and is a wholly owned subsidiary of BG Energy Holdings Limited

The Company was established to act as the trustee of the BG Group Employee Profit Sharing Scheme (the 'Scheme'), an Inland Revenue approved employee share scheme established for the benefit of employees of participating subsidiary undertakings of BG Group plc in accordance with the terms of the Trust Deed and Rules dated 13 March 2000. The Scheme ceased to operate in 2002 with the last transfer to participants taking place in April 2004.

No shares have been appropriated to participants under the Scheme since 2001 and as the Scheme ceased to operate in 2002, no further appropriations will be made. All shares appropriated by the Trust have now been transferred to participants.

Results and Dividend

The Company has no income (2008 £nil) Each participating company covenants to pay all of the costs and expenses incurred by the trustees in the establishment, operation and determination of the Scheme

The Directors do not propose to declare a final dividend in respect of the year ended 31 December 2009 (2008 £nil)

1 Ultimate parent undertaking
