**INTRODUCTION**

The Company was placed into members’ voluntary liquidation on 27 July 2011 and Tim Walsh and Laura Waters were appointed joint liquidators (“the Liquidators”)

In accordance with section 94 Insolvency Act 1986, the Liquidators are required to report on the conduct and outcome of the liquidation. This report is for the period 27 July 2011 to 5 April 2012 and also serves as a progress report from 27 July 2011 to 5 April 2012 to the extent required by Section 92A Insolvency Act 1986.

We are also required to provide certain information concerning the Company and the Liquidators, this information is attached as appendix A

We set out a summary of the Liquidators’ receipts and payments for the liquidation as appendix B

**REPORT ON THE LIQUIDATION**

**Realisation of assets:**

The directors’ Declaration of Solvency disclosed that the Company has no assets

No additional assets have been identified There are no assets still to be realised

**Settlement of liabilities:**

This section covers all liabilities except any claims of Her Majesty’s Revenue & Customs (“HMRC”) which are dealt with separately below under HMRC

The directors’ Declaration of Solvency and the Company’s records disclosed that the Company had no liabilities.

Following their appointment, the Liquidators published a notice in the Gazette inviting any unknown creditors to submit their claims.

There are no residual claims to be agreed or settled

**HMRC:**

The directors’ Declaration of Solvency and the Company’s records disclosed that the Company had no liabilities.

Following their appointment, the Liquidators wrote to HMRC to advise of their appointment and to seek confirmation of any outstanding liabilities HMRC have confirmed that the Company has no outstanding liabilities

All matters outstanding with HMRC, have now been cleared and HMRC have confirmed their agreement to the liquidation being closed without further reference to them

**Distributions to members:**

At the time of the Liquidator’s appointment, the issued share capital of the Company was 100 ordinary £1 shares.

**LIQUIDATORS’ REMUNERATION AND EXPENSES**

**Basis of remuneration:**

At the time of the Liquidators’ appointment by the members of the Company, a resolution was passed making provision for the Liquidators to be remunerated by reference to the time properly given by them and their staff in attending to the matters arising in the winding up.

**Funding of the liquidation:**

Although fees have been paid to the Liquidators on the basis specified above, neither the Liquidators’ fees nor their expenses have been paid out of the liquidation estate. Instead, the Liquidators’ remuneration and expenses in relation to the Company and 2 connected companies have been met by Dow Chemical Company Limited.

**Remuneration charged / expenses incurred:**

The amounts shown below relate to the Company and the 2 connected companies referred to above

During the liquidation, up to 5 March 2012, the Liquidators have incurred time costs of £8,218. This represents 34 hours at an average hourly rate of £242. Against this, £3,761 has been invoiced and paid. The remainder will be invoiced in due course along with further costs incurred through to the conclusion of the liquidation.

The Liquidators have incurred expenses of £862 plus VAT. These costs, which have been re-charged as incurred, comprise.
