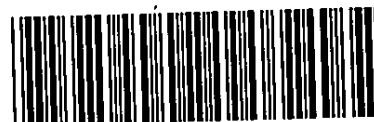

THIS ASSIGNMENT made the 25th day of March 2014 BETWEEN (1) BOWBROOK INTERNATIONAL FOOD LTD (the "Beneficiary") and (2) BRITISH ARAB COMMERCIAL BANK PLC (the "Bank") WITNESSES as follows

INTRODUCTION

- A The Bank has confirmed a Letter of Credit (the "Original Letter of Credit") numbered 010CD146426142 and dated 11/03/2014 opened by Algeria Gulf Bank in favour of the Beneficiary
- B The Beneficiary has requested the Bank to open a Letter of Credit (the "Back to Back Letter of Credit") in favour of Silver Fern Farms Ltd, on its behalf on the same terms as the Original Letter of Credit
- C The Beneficiary has agreed to assign to the Bank all amounts due to it under the Original Letter of Credit as security for the Bank's liabilities under the Back to Back Letter of Credit.
- D The Beneficiary has also agreed to deposit with the Bank the documents (the "Original Documents") required to be presented under the terms of the Original Letter of Credit

ASSIGNMENT

- 1 This Assignment shall be security for the payment and discharge of the monies and liabilities hereinafter defined
- 2. The words "monies and liabilities" used herein mean all monies and liabilities which now are or shall at any time hereafter be due owing or incurred to the Bank in respect of the financial accommodation provided by the Bank to the Beneficiary in order to open the Back to Back Letter of Credit on its behalf whether actually or contingently and whether presently or in the future and whether solely or jointly with any other person and whether as principal or surety or in any way whatsoever including (as well after as before any demand made or judgment obtained) interest discount commission and other lawful charges and expenses computed and compounded from time to time in accordance with the terms agreed between the Beneficiary and the Bank relating thereto (if any) and in the absence of any such agreed terms computed and compounded from time to time according to the then current practice of the Bank (but so that interest shall be computed at the rate of 2 per centum per annum over the Bank's base rate from time to time ruling).
- 3 The Beneficiary with full title guarantee assigns to the Bank ALL the sum or sums of money (the "Debt") now or at any time hereafter to become due owing and payable to the Beneficiary in any way whatsoever under and by virtue of the Original Letter of Credit Together with all interest due or to become due thereunder and the benefit of all the provisions thereof and all securities (if any) therefore TO HOLD the same unto the Bank subject to the proviso for redemption hereinafter contained

- 4 The Beneficiary will deposit with the Bank and allow the Bank to keep the Original Documents until the monies and liabilities are discharged
- 5 If the Beneficiary shall pay and discharge to the Bank the monies and liabilities the Bank will at the cost and request of the Beneficiaries reassign the Debt to the Beneficiary or as he shall direct or otherwise discharge this security
- 6 During the continuance of this security the Beneficiary will to the best of his ability comply strictly with all the obligations imposed upon him by the Original Letter of Credit and will do no act or commit no default as a result of which the entitlement of the Beneficiary to the Debt may be avoided reduced abated or delayed
- 7 The Beneficiary hereby irrevocably appoints the Bank the agent and attorney of the Beneficiary for the collection of the Debt and to that end the Bank may in the name of the Beneficiary and on the Beneficiary's behalf
- (a) collect and get in the Debt and for that purpose to make such demands and take such proceedings as may seem expedient,
 - (b) sell or assign the benefit of the Original Letter of Credit,
 - (c) make any compromise or arrangement in respect of the Debt or the Original Letter of Credit that may seem expedient,
 - (d) execute any documents or deeds that may be required or desirable for the purposes hereof including but not limited to the amendment and/or completion of the Original Documents, and
 - (e) do all such other acts and things as the Bank may consider to be incidental or conducive to any of the matters or powers as aforesaid including but not limited to the presentation of the Original Documents

PROVIDED always that it shall not be incumbent on the Bank to take any steps or institute any proceedings in the recovery of the Debt nor shall the Bank be liable for any loss arising from his not having taken such steps or instituted such proceedings.

~~8 The restriction on the right of consolidating mortgages contained in Section 93 of the Law of Property Act 1925 shall not apply to this Assignment.~~

9 The Bank may at its sole discretion set off the monies and liabilities against its liabilities to the Mortgagor under the Original Letter of Credit

10 This Assignment

- (a) Shall be in addition to and shall be independent of every other security which the Bank may at any time hold for any of the monies and liabilities; and it is hereby declared that no prior security held by the Bank over the whole or any part of the Debts shall merge in the security created by this Assignment;
- (b) shall remain in full force and effect as a continuing security unless and until the Bank reassigns the Debt

- 11 The Bank may in its discretion grant time or other indulgence or make any other arrangement variation or release with any person or persons not party hereto (whether or not such person or persons are jointly liable with the Beneficiary) in respect of any of the monies and liabilities or of any other security therefore without prejudice either to this Assignment or to the liability of the Beneficiary for those monies and liabilities
- 12 Any demand or notice under this Assignment may be made or given by any manager or officer of the Bank or of any branch thereof by letter addressed to the Beneficiary and delivered to any officer of the Beneficiary at any place or sent by first class post to or left at the registered office of the Beneficiary or any place of business or activity of the Beneficiary last known to the Bank and if sent by post shall be deemed to have been made or given at noon on the day following the day the letter was posted and shall be effective notwithstanding that it be undelivered or be returned undelivered.
- 13 All the costs charges and expenses of the Bank including the costs charges and expenses incurred in the carrying of this Assignment into effect or in the exercise of any of the rights and remedies and powers conferred hereby shall be paid by the Beneficiary
- 14 The rights and remedies of the Bank herein provided are in addition to and not in substitution for any rights or remedies provided by law
- 15 This Assignment shall be governed by and construed in accordance with English law and the Beneficiary submits to the non-exclusive jurisdiction the Courts of England and Wales
