The Directors present their report and financial statements of Boo TV Limited (the "Company") for the year ended 28 February 2010

Principal Activities and Review of the Business

The principal activity of the Company continues to be the holding and exploitation of character rights and brands

The Company has met the requirements within Companies Act 2006 to obtain the exemption from the presentation of an enhanced business review

Comparative period

The comparative period presented in these financial statements is for the 14 month period ended 28 February 2009

Directors' indemnities

As permitted by the Articles of Association, the Directors have the benefit of an indemnity which is a qualifying third party indemnity provision as defined by Section 234 of the Companies Act 2006. The indemnity was in force throughout the last financial year and is currently in force. The Company, through its parent undertaking as part of the UK based group operations, also purchased and maintained throughout the financial year Directors' and Officers' liability insurance in respect of itself and its Directors.

Financial risk management

As disclosed in note 1, referenced in turnover, all trading is via Classic Media Distribution Limited (a fellow Group company), as such the Company does not have any material financial risk exposure

Political and charitable contributions

The Company made no political or charitable donations or incurred any disclosable political expenditure during the year (2009 £Nil)

Going Concern

The financial statements for the period ended 28 February 2010 have been prepared on a going concern basis, notwithstanding the net liability of £1,083,682, since the intermediate parent of the Company, Boomerang Media Holdings LLC, has issued a letter of support stating that it is its current intention to make sufficient funding available to the Company to trade and to meet its obligations as and when they fall due for the foreseeable future, being a period of at least twelve months from the date of approval of these financial statements

Notes to the financial statements

1. Accounting Policies

Basis of preparation

These financial statements have been prepared under the historical cost convention and in accordance with applicable. United Kingdom accounting standards. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements.

Going concern

As noted in the Directors' report, these financial statements have been prepared on a going concern basis, notwithstanding the net liability of £1,083,682 as at 28 February 2010, since the intermediate parent of the Company, Boomerang Media Holdings LLC, has issued a letter of support stating that it is its current intention to make sufficient funding available to the Company to trade and to meet its obligations as and when they fall due for the foreseeable future, being a period of at least twelve months from the date of approval of these financial statements

Turnover

Television distribution and production

Turnover represents royalties paid to the Company by Classic Media Distribution Limited ("CMDL"), a UK based related party CMDL has been nominated as the operating entity of the group, acting as principal in sale transactions, utilising the intellectual property owned by the Company and the other companies within the group. A royalty is paid to the Company by CMDL to compensate for use of its intellectual property.

Taxation

The charge for taxation is based on the profit for the period and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes. Deferred taxation is provided on all timing differences, without discounting, which have arisen but not reversed by the balance sheet date, except as otherwise required by FRS19.

Cash flow statement and related party disclosures

The Company is a wholly-owned subsidiary of Classic Media UK Limited and is included in the consolidated financial statements of Classic Media UK Limited, which are publicly available. Consequently, the Company has taken advantage of the exemption from preparing a cash flow statement under the terms of FRS1 (revised). The Company is also exempt under the terms of FRS8 from disclosing related party transactions with entities that are part of the Classic Media UK Limited group.

2. Turnover

The total turnover of the Company for the period has been derived from its principal activity wholly originating in the United Kingdom and predominantly destined for the United Kingdom Further disclosures have not been provided in respect of loss before taxation and net liabilities as the Company operates solely in the United Kingdom

Restatement

Classic Media Distribution Limited ("CMDL"), a UK based related party, has been nominated as the operating entity and acts as principal in sale transactions, utilising the intellectual property owned by the Company Following the change of ownership of the group, the presentation of turnover and cost of sales relating to these transactions has been amended. A royalty is paid to the Company by CMDL to compensate for use the intellectual property. This is presented in turnover

This change in presentation has no net impact on gross profit or profit before tax. The following line items have been restated in the comparative figures to these financial statements.
