1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2 Turnover

Turnover comprises revenue recognised by the company in respect of services provided during the year, exclusive of Value Added Tax.

Revenue is recognised in the period in which services are provided.

3. DIRECTORS' BENEFITS: ADVANCES, CREDIT AND GUARANTEES

Included within debtors due within one year is a short-term loan to F L Iseman, a director of the company, amounting to £39,580 (2013 - £30,768), which was repaid in full after the year end. The maximum outstanding balance during the year was £56,035. Interest of £1,401 (2013 - £1,113) has been charged at the HMRC beneficial loan rate.
