ADDITIONAL PROVISIONS TO THE MODEL ARTICLES FOR PRIVATE COMPANIES LIMITED BY GUARANTEE

Objects

40. The company's objects are to promote and encourage greater diversity within the media industry

Application of Income and Property

- 41. (1) The income and property of the company shall be applied solely towards the promotion of the company's objects
 - (2) None of the income or property of the company may be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to any member of the company

Dissolution

- 42. (1) The members of the company may, at any time before and in expectation of its dissolution, resolve that any net assets of the company, after all its debts and liabilities have been paid or provision has been made for them, shall, on or before the dissolution of the company, be applied or transferred in any of the following ways:
 - (a) directly for the objects of the company, or
 - (b) by transfer to any company or charity for purposes similar to the objects of the company; or
 - (c) to any company or charity for use for particular purposes that fall within the objects of the company.
 - (2) Subject to any such resolution of the members of the company, the directors of the company may, at any time before and in expectation of its dissolution, resolve that any net assets of the company, after all its debts and liabilities have been paid or provision has been made for them, shall, on or before the dissolution of the company, be applied or transferred in any of the following ways:
 - (a) directly for the objects of the company, or
 - (b) by transfer to any company or charity for purposes similar to the objects of the company, or

- (c) to any company or charity for use for particular purposes that fall within the objects of the company
- (3) In no circumstances shall the net assets of the company be paid to or distributed among the members of the company (except to a member that is a charity) and if no resolution in accordance with article 42(1) is passed by the members or the directors the net assets of the charity shall be applied for charitable purposes as directed by the Court or the Charity Commission for England and Wales
