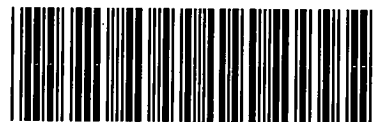

The Directors of Leyland Bus Trustees Limited present their report and the unaudited financial statements for the year ended 5 April 2014.

PRINCIPAL ACTIVITY AND REVIEW OF THE BUSINESS

The Company was incorporated on 6 April 1988 as a company limited by guarantee without a share capital. Each member of the Company undertakes to contribute a maximum of £1 to the assets in the event of the Company being wound up while he or she is still a member and for a period of one year after he or she ceases to be a member.

The Company's business is to act as sole corporate trustee to the Leyland Bus Pension Scheme (the Scheme). The Company also became the principal employer of the Scheme on 11 September 2002. No change to this is expected in the future. The Company's profit for the year amounted to £nil (2013: £nil).

NOTES TO THE ABBREVIATED FINANCIAL STATEMENTS

For the Year Ended 5 April 2014

- 1 Accounting Policy - The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).
- 2 Profit and loss account - The Company acted as a trustee company and did not receive any income nor incur any expenditure for the year to 5 April 2014. The expenses of the Company have been borne by the pension scheme of which the Company is a trustee without any right of reimbursement. There are no employees and so no remuneration has been paid to Directors and employees (2013: nil). Accordingly no profit and loss account is presented. There have been no other recognised gains and losses in the current or prior year.
- 3 Share capital - The Company has no share capital, being limited by member guarantee only. Each member of the Company undertakes to contribute a maximum of £1 to the assets in the event of the Company being wound up while he or she is still a member and for a period of one year after he or she ceases to be a member.
