1. Statement of Compliance

Pro-Bel Developments Limited is a limited liability company incorporated in England. The registered office is 31 Turnpike Road, Newbury, Berkshire, RG14 2NX.

These Financial Statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland.

2. Accounting policies

Basis of preparation

The financial statements are prepared under the historical cost convention, in accordance with applicable accounting standards and within the requirements of the Companies Act 2006.

Transition to FRS 102

The entity transitioned from previous UK GAAP to FRS 102 as at 1 January 2014. Details of how FRS 102 has affected the reported financial position and financial performance is given in note 9.

Disclosure exemptions

The entity satisfies the criteria of being a qualifying entity as defined in FRS 102. Its financial statements are consolidated into the financial statements of Quantel Holdings Limited which can be obtained from their registered office (see note 8). As such, advantage has been taken of the following disclosure exemptions available under paragraph 1.12 of FRS 102:

- (a) No cash flow statement has been presented for the company.
- (b) Disclosures in respect of financial instruments have not been presented.
- (c) No disclosure has been given for the aggregate remuneration of key management personnel.

Income statement

The company is dormant as defined by section 1169 of the Companies Act 2006. The company received no income and incurred no expenditure during the current year or prior year and therefore no income statement is presented within these Financial Statements. There have been no movements in shareholders' funds during the current year or prior year.

Consolidation

The company is exempt under Section 400 of the Companies Act 2006 from the requirement to prepare consolidated financial statements for the year ended 31 December 2015 as it is a wholly owned subsidiary undertaking of Pro-Bel Group Limited and its results are included within the consolidated financial statements of Quantel Holdings Limited. These financial statements present information about the company as an individual company and not about its group.
