1. STATUTORY INFORMATION

16 Sheen Gate Gardens Ltd is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The Company transitioned from previously extant UK GAAP to FRS102 as at 1 January 2015. However due to such transition there has been no effect in the reported financial position and financial performance of the Company.

Income

Income represents ground rents, which are recognised on a receivable basis.

Service charges

The company collects service charges from residents and incurs costs in respect of maintenance of the common parts in accordance with the lease. In accordance with accounting guidance these transactions are not included in these financial statements. Income and expenditure arising from these transactions is shown in separate service charge accounts that do not form part of the annual accounts of the company and which are not filed at Companies House. All service charge monies received from the residents are held on trust for the residents in accordance with section 42 of the Landlord and Tenant Act 1987.
