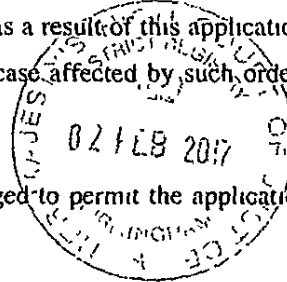
ORDER

UPON THE APPLICATION of the Applicants dated 17/11/16

AND UPON READING the evidence

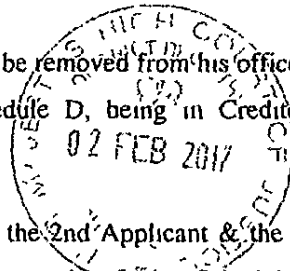
IT IS ORDERED

- 1 That the Applicants have leave to make a composite application in respect of the insolvency proceedings identified in the Schedules A to H attached to this Application (Schedules),
- 2 That the proceedings listed in the Schedules, in so far as there are currently proceedings in any County Court or any District Registry in England & Wales other than the Birmingham District Registry, be transferred to the Birmingham District Registry solely for the purpose of considering and, if thought fit, making the orders listed below,
- 3 That the Applicants do ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the Court having jurisdiction over each case affected by such order for filing on the Court file relating to that case,
- 4 That the time for service of this application be abridged to permit the application to be heard at such time as this Court shall think fit,
- 5 Pursuant to Paragraph 88 of Schedule B1 to the Act, Nigel Price (the 1st Respondent), be removed from his office as joint administrator of the companies identified in Schedule A, being in administration,
- 6 Pursuant to Section 13, Paragraphs 63, 91 and 95 of Schedule B1 to the Act and Rule 7 10B(2) of the Rules, Gareth Prince (the 1st Applicant), Mark Malone (the 2nd Applicant) & William John Kelly (the 3rd Applicant) be appointed as joint administrator of the respective companies identified in Schedule A, being in administration, and marked with their respective names, to act jointly and severally with the existing administrators;
- 7 Pursuant to Section 298 of the Act and Rule 7 10B(2) of the Rules, the 1st Respondent be removed from his office as trustee in bankruptcy of the individuals listed in Schedule B, being in bankruptcy,
- 8 Pursuant to Sections 298 and 303(2) of the Act and Rule 7 10B(2) of the Rules, William John Kelly (the 3rd Applicant) & Joanne Wright (the 4th Applicant) be



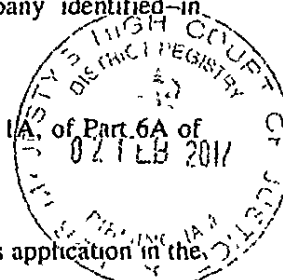
appointed as trustees in bankruptcy of the individuals listed in Schedule B attached hereto;

- 9 Pursuant to Section 7(5) of the Act, the 1st Respondent be removed from his office as joint supervisor of the company voluntary arrangements identified in Schedule C,
- 10 Pursuant to Section 7(5) of the Act, the 2nd Applicant be appointed as joint supervisor of the company voluntary arrangement of GYG Holdings Limited identified in Schedule C, and marked with his name, to act jointly and severally with the existing supervisor;
- 11 Pursuant to Section 108 of the Act, the 1st Respondent, be removed from his office as joint liquidator of the companies identified in Schedule D, being in Creditors' Voluntary Liquidation,
- 12 Pursuant to Section 108 of the Act, the 1st Applicant, the 2nd Applicant & the 3rd Applicant, be appointed as joint liquidator of the companies identified in Schedule D, being in Creditors' Voluntary Liquidation, and marked with their respective names, to act jointly and severally with each other, or with the existing liquidator respectively,
13. Pursuant to Section 263(5) of the Act, the 1st Respondent be removed from his office as supervisor of the individual voluntary arrangements identified in Schedule E,
- 14 Pursuant to Section 7(5), of Schedule 1 of the Insolvent Partnership Order 1994, the 1st Respondent be removed from his office as joint supervisor of the partnership voluntary arrangement identified in Schedule F,
- 15 Pursuant to Section 108, the 1st Respondent be removed from his office as joint liquidator of the companies listed in Schedule G, being in Members' Voluntary Liquidation,
- 16 Pursuant to Section 108, the 2nd Applicant be appointed as joint liquidator of the companies listed in Schedule G, being in Members' Voluntary Liquidation, to act jointly and severally with the existing liquidator,
- 17 Pursuant to Section 172(2) of the Act and Rule 7 10B(2), the 1st Respondent be removed from his office as joint liquidator of the company identified in Schedule H, as being subject to a Compulsory Winding Up Order,



- 18 Pursuant to Section 168(3) & (5) of the Act and Rule 7 10B(2) of the Rules, the 1st Applicant, the 2nd Applicant & Sally Richards (the 5th Applicant) be appointed as joint liquidators of the company identified in Schedule H as being subject to a Compulsory Winding Up Order, and marked with their respective names, to act jointly and severally with the existing liquidator,
- 19 The creditors of the companies and the individual listed in the Schedules be notified of the Order by advertisement in the London Gazette within 14 days of receipt of the Order by the Applicants and at the time of the next statutory reporting requirement for each case,
- 20 Pursuant to paragraph 98 of Schedule B1 to the Act, Section 7(4) of the Act, Section 7(4) of Schedule 1 of the Insolvent Partnership Order 1994 and Section 263(4) of the Act, the 1st Respondent be discharged from liability in respect of any action of his as administrator or supervisor of the companies, the partnership and individuals listed in Schedules A, C, E and F, with effect from 28 days after the relevant notice referred to in paragraph 19 above has been advertised, save in respect of any claim notified to the Respondents or the Applicants, by that date
- 21 Pursuant to Rule 4 121, Rule 4 122, Rule 4 144 and Rule 6 135 of the Rules, the 1st Respondent shall be at liberty to apply to the Secretary of State for his release, as liquidator (whether voluntary or compulsory) or trustee in bankruptcy of the companies and the individuals listed in Schedules B, D, G and H, with effect from 28 days after the relevant notice referred to in paragraph 19 above has been advertised, save in respect of any claim notified to the Respondents or the Applicants, by that date
- 22 The Applicants shall notify the Secretary of State of the Order as soon as reasonably practicable after it is made,
- 23 All creditors of the companies and the individuals listed in the Schedules do have permission to apply to the Court, on notice to the Applicants, within 28 days of being given notice of the terms of the Order, for the purposes of applying to vary or discharge the Order in so far as it affects the company or companies or individual's estates of which they are a creditor,
- 24 Pursuant to Rules 2.47(3A) and Rule 12A.55(2) of the Rules, the time for the filing of the progress report in the administration of the companies listed in Schedule A be extended to the date of the next scheduled report,

- 25 Pursuant to Rule 6.78A(4) and Rule 12A.55(2) of the Rules, the time for the filing of the progress report in the bankruptcy of the individuals listed in Schedule B attached hereto be extended to the date of the next scheduled report,
- 26 Pursuant to Rule 4.49C and Rule 12A.55(2) of the Rules, the time for the filing of the progress report in the creditors' voluntary liquidations of the companies listed in Schedule D be extended to the date of the next scheduled report in each case,
- 27 Pursuant to Rule 4.49C and Rule 12A.55(2) of the Rules, the time for the filing of the progress report in the members' voluntary liquidations of the companies listed in Schedule G be extended to the date of the next scheduled report in each case,
- 28 Pursuant to Rule 4.49B(5) and Rule 12A.55(2) of the Rules, the time for the filing of the progress report in the compulsory liquidation of the company identified in Schedule H be extended to the date of the next scheduled report,
- 29 Rule 2.122 of the Rules is overridden and dis-applied by Chapter 1A, of Part 6A of the Rules
- 30 There be no order as to costs, save that the Applicants' costs of this application in the sum of £3,723 plus VAT, plus the Court fee of £155, and the London Gazette fee to advertise the Order which is estimated at £1,000 plus VAT, be charged as a cost or expense of the estates listed in the Schedules (each estate to bear an equal share, or such other share as the Applicants may decide but with no estate having to bear an amount exceeding 10% of the value of the available funds in the estates as at the date of this Order),
- 31 Immediately upon this order taking effect, any cases listed in the Schedules which, pursuant to paragraph 2 above are transferred to the Birmingham District Registry be transferred back to the County Court or District Registry from which they originated,
- 32 Compliance with Rule 7.10D(3) of the Insolvency Rules 1986 is varied so that lodging of a certified copy of this Order, once sealed, with each Court is deemed to be compliant with that Rule
- 33 Rule 4(5)(b) of the Insolvent Companies (Report on Conduct of Directors) Rules 1996 (*SI 1996/1909*) shall (if but for this order it would apply) not apply and the 1st Respondent is not required to submit any reports in respect of any of the administrations and the voluntary liquidations listed in Schedules A and D
