The Directors/Trustees present their report with the financial statements of the company for the year ended 31 March 2017, having had regard to relevant SORP requirements. When preparing this report the Trustees have also referred to the guidance in the Charity Commission's general guidance on public benefit when reviewing and reporting on the charity's delivery of aims and objectives. In particular, the trustees have considered how planned activities will contribute to meeting stated aims and objectives. This report is designed to be read in conjunction with the 'easy-read' element.

WHAT LEWISHAM SPEAKING DOES

Objectives and activities that are for public benefit

The company is a charity that works to support and provide advocacy services to people with learning disabilities, particularly in the south east London borough of Lewisham. Our charitable objectives are:

- (a) to relieve and support people disadvantaged by learning disability, difficulty or special need through advocacy services which promote their rights and entitlements as equal citizens:
- (b) to advance and promote education of all people with learning disabilities through group work, training, and other relevant advocacy practice;
- (c) to advance the education of the public about the educational, physical, emotional, and psychological needs of people with learning disabilities.

REVIEW OF THE YEAR'S ACTIVITY AND RESULTS

Lewisham Speaking Up is an independent advocacy project for people with learning disabilities, led by people with learning disabilities. We are based in The Deptford Albany in the borough of Lewisham, south east London. We support people with learning disabilities to have a stronger voice, to speak up for themselves as self advocates or with the help of a 1-2-1 advocate. This report is about our activities and outcomes for the people we support and who participated in our activities during the twelve months from April 2016 to March 2017.

In June 2016 our Director, Peter Smith, retired. Peter set up Lewisham Speaking Up in 2004 and maintained his strong commitment to advocacy for people with learning disabilities in Lewisham over many years. We are grateful for his hard work and dedication, and that he left the organisation in a position to continue to grow and develop. We wish him a long and happy retirement.

Following our successful applications to several charitable trusts we were very pleased to launch two new projects in July 2016:

Lewisham People's Parliament is funded by a three year grant from Comic Relief. The project started in July with the appointment of the Project Lead.

Between July 2016 and March 2017 we held three People's Parliaments which were attended by 181 people. At the first one in October participants learnt about the new LSUP projects and selected six people as parliament representatives and a further six people as Hate Crime trainers. The Reps will represent people with a learning disability at meetings with decision makers following each People's Parliament.

The second Parliament in December addressed the theme of Friendships where people with a learning disability were consulted on what the barriers are to forming friendships and

relationships. We discovered during this event that many people with a learning disability are lonely sometimes and don't always get to go out when they want to. The findings from this Parliament contributed to our application to Deptford Challenge Trust to establish a Wellbeing Speaking Up Group

We held a Parliament in March on employment. People said they wanted more support when attending the jobcentre, they want letters sent to them by the jobcentre to be in Easy Read format, and they want more job opportunities.

We had good feedback from all three Parliaments. For all three events over 90% of people who attended said the Parliament was good.

Our second new project which also started in July is our Hate Crime Advocacy Project funded by Trust for London and City Bridge again to run over three years. We appointed the Hate Crime Advocacy Lead and six paid Stop Hate Crime Trainers, all of whom have learning disabilities. As a team they will engage with groups of people with learning disabilities living in communities in Lewisham to educate people regarding hate crime: how to recognise it, and how to report it. They will also engage with schools in Lewisham to raise awareness amongst younger people about learning disability hate crime, how it affects people, and how to report it if they encounter it. The first year's work began by training our trainers and starting work on producing a film showing what is hate crime and how to report it. The film was launched in September 2017 and will be an important tool in delivering our training.

During the year we applied successfully to the Mayor's Office for Policing and Crime Victims Fund and were awarded a grant to set up and run one to one advocacy for people with learning disabilities who were victims of crime and hate crime. This work which starts in July 2017 will support and develop the Hate Crime training work by enabling us to provide individual support and advocacy for people who are victims of crime.

We continue to receive a grant from London Borough of Lewisham which contributes to our core activities of one to one advocacy and self-advocacy work.

During this period our Advocacy Service Manager continued to steer and oversee our main advocacy activity areas. 88 people received advocacy support either through volunteers or from short term advocacy and signposting and were helped with 172 issues. We reduced our waiting list from 33 at the beginning of the year to 20 in December 2016 and have taken steps to reduce this further. We trialled an Advocacy Surgery where people on the waiting list could drop in and speak to a volunteer advocate: Four people were helped through this process.

Eight Big Group meetings were held this year and our highest attendance was 40 people with a learning disability coming in January 2017. The issues that people spoke up about included health, independence, and cuts to services. We were pleased to hold our first ever Big Group for people attending day services at the Mulberry Centre: this meant people who attend the day service had their say on what they wanted Big Groups to be about.

Our Voice for Life group ran at the Albany and at Lewisham College. 14 people attended our regular group at The Albany and during this period we also started a group at Lewisham and Southwark College where, in total, 27 students with a learning disability accessed the group. Groups supported people to speak up, identify barriers to speaking up, speak about relationships, and transition.

We completed the second Quality Checking programme of Lewisham Day Services on behalf of London Borough of Lewisham Learning Disability Commissioning, working with a team of Quality Checkers with a learning disability to check each day service in the borough and find out what people thought of their service. Reports were then submitted to Lewisham Commissioners.

Lewisham Speaking Up arranged for self-advocates to take part in a 'Photosymbols' photo shoot. The photo shoot was enjoyable for the many people who took part. We now have LSU self-advocates in the Photosymbols library and LSU have access to an extremely valuable resource which supports and builds on our commitment to Easy Read.

We aim to be active in our local community through participation in events such as Lewisham People's Day and working with Voluntary Action Lewisham, Healthwatch Lewisham and attending events and planning joint activities as appropriate. We have also sustained strong working links with Lewisham Council and other service providers in the area.

The organisation continues to work to maintain quality and responsiveness, to ensure that we are a fully inclusive organisation with a strong voice for people with learning disabilities. We have reviewed and evaluated areas of our work through the PQASSO quality standard throughout the year.

RESULTS

The total incoming resources for the year amounted to £182,877 with an expenditure of £149,262

The charity operates for the public benefit by:

- providing self-advocacy groups and larger events for people with learning disabilities based at the Deptford Albany and other venues; supporting self-advocates to participate in meetings and events, local, regional and national; providing specialised training and support for people with learning disabilities that supports their full participation in society and their ability to raise awareness of issues that affect them amongst the wider community;
- 1-2-1 Advocacy support where our main approach is to recruit, train and prepare
 volunteer advocates who provide advocacy support that is in response to self or
 professional referral. Advocacy support provided by volunteer advocacy partners is
 generally short to medium term, and in response to issues, problems or changes with
 services, in particular where independence from service provider conflict is critical.

FUTURE STRATEGY

The Board of Trustees remains committed to taking Lewisham Speaking Up forward in line with its objectives, as a grassroots advocacy charity, rooted in direct engagement with people with learning disabilities. People with learning disabilities in Lewisham are the core focus of our work and we continue to strive to tackle discrimination, enable access to services and promote their voice to decision makers – both collectively and as individuals.

Our local knowledge and reputation with Lewisham-based stakeholders is a significant strength, as is our cooperation with the London Borough of Lewisham. This collaborative approach contributes to our sustainability and enables us to better meet our objectives. We

have recognised challenges in the funding environment and acted upon this, building on our Local Authority grant with additional funding to ensure that we are able to carry on building our work on a sustainable foundation. We therefore remain optimistic despite the challenging environment.

It continues to be clear our beneficiaries value Lewisham Speaking Up and have benefited from better self-esteem, a greater ability to articulate their needs to service providers and improved choices through our support. The national policy environment has further increased the need for independent advocacy for people with learning disabilities and the support we offer is thus even more critical for their wellbeing.

When considering future strategy, Trustees will take careful account of how to meet ongoing challenges with continued emphasis upon delivering high quality advocacy provision for our beneficiaries.

RESERVES POLICY

The Directors/Trustees want to make sure the money that Lewisham Speaking Up receives is used to help us to do what we set out to do. They want to make sure our money doesn't just sit in the bank and that it helps us achieve our aims. But they think Lewisham Speaking Up needs to have some money in reserve in case something unexpected happens. The increasingly difficult financial climate makes a sudden reduction in our funding more likely.

For these reasons Lewisham Speaking Up needs money in reserve that will give us time to plan, find more money, or change things. The Directors/Trustees think Lewisham Speaking Up also needs enough money in reserve to make sure they can carry out their responsibilities as a good employer. They think that the amount of money needed in reserve should be about the same as no less than three but no more than six months' core expenditure (day to day running costs), so that is their agreed target.

The Directors/Trustees have reviewed the current level of reserves and agreed to designate an amount of reserves to invest in the organisation's management and development during 2017/18. These are shown in Note 12.

INVESTMENT POLICY

The company will keep its money in an interest-bearing deposit account but review this approach as circumstances change.

RISK REVIEW

The Directors/Trustees continue to be of the view discontinuation or reduction in grant funding to be the main risk to our activity and are pleased with the steps we have taken to diversify our funding base over the past twelve months.

Notwithstanding the above, we continue to believe that a local grant is vital to core stability, and we remain of the view that grants better sustain local beneficiary-led groups such as ours.

We believe that the benefits and added value that beneficiary led and locally rooted groups bring should be attractive to local funders. We believe this is recognised by Lewisham who acknowledge this by sustaining a grant programme.

During the year the Directors/Trustees have agreed a fundraising strategy and priorities to sustain and develop the work of Lewisham Speaking Up.

Internal policies (including financial) are in place to minimise risk and ensure service and operational quality for the charitable company.

MEMBERS OF THE BOARD OF TRUSTEES

Members of the Board of Trustees, who are Directors for the purposes of company law and Trustees for the purpose of charity law, who served during the year up to the date of this report, are set out at the front of this report.

Members of the charitable company guarantee to contribute an amount not exceeding £10 to the assets of the charitable company in the event of winding up. The total number of such quarantees at 31 March 2017 was 8.

STATEMENT OF DIRECTORS'/TRUSTEES' RESPONSIBILITIES

Company law requires the Directors/Trustees to prepare annual accounts which give a true and fair view of the state of the company's affairs and of the surplus or deficit of the company for that period.

In preparing the company's accounts, Directors/Trustees are required to:

- consistently apply suitable accounting policies and make judgements and estimates that are reasonable and prudent;
- prepare the accounts on a going concern basis unless it is appropriate to presume that the company will not continue to carry on its business.

The Directors/Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any particular time the financial position of the company. They are also responsible for safeguarding the assets of the company and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In accordance with company law, as the company's directors, we certify that:

- as the directors of the company we have taken all the steps that we ought to have taken in order to make ourselves aware of any relevant audit information and to establish that the charity's auditors are aware of that information.

LEWISHAM SPEAKING UP NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2017

1. ACCOUNTING POLICIES

1.1 Basis of preparation

The accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Companies Act 2006.

The charity constitutes a public benefit entity as defined by FRS 102.

The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern.

1.2 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:

Plant and machinery 33% on cost Fixtures, fittings and equipment 33% on cost

1.3 Fund accounting

Funds held by the charity are either:

- Unrestricted general funds, which can be used in accordance with charitable objects at the discretion of the trustees, and unrestricted designated funds which are unrestricted funds set aside by the trustees for particular purposes; or
- Restricted funds, which can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
