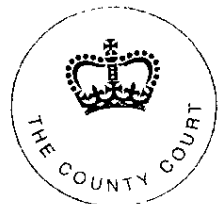
AND UPON READING the evidence

be deemed to have continued in existence as if its name had not been struck  
off

(4) the Registrar of Companies do advertise notice of this Order in his official  
name in the "London Gazette"



(5) the hearing fixed for the 4<sup>th</sup> January 18 ~~42<sup>th</sup> September 2017~~ be vacated

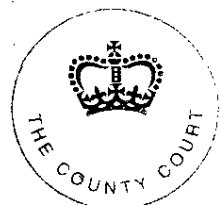
