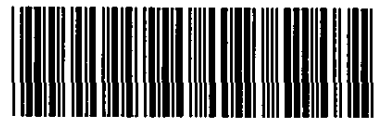



NOTES TO THE ACCOUNTS

For the year ended 31 January 2013

1) ACCOUNTING POLICIES

The accounts have been prepared in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008) and under historical cost convention adopting the principal accounting policies in accordance with the applicable accounting standards

2) SHARE CAPITAL

The Company is limited by guarantee and has no share capital

3) PRINCIPAL ACTIVITY

The Company is a Residents Management Company and operates as a non profit making organisation. Its principal activity is that of management and maintenance of the common area of the property at The Old George, Nailsworth. There were no material transactions during the year other than for collection of service charges from the residents in order to fund the relevant costs in relation to the aforesaid property. Under section 42 of the Landlord and Tenant Act 1987, the company has entered in to these transactions as a trustee and any funds held by the Company are held in trust for the residents. The Company is therefore a dormant company.
