IT IS ORDERED THAT:

In respect of those administrations, creditors' voluntary liquidations and compulsory liquidations listed in Schedule 2 to this Order which are the subject of proceedings in County Courts and District Registries in England and Wales and in the courts

outside of England and Wales pursuant to the EC Regulation on Insolvency Proceedings 2000 and the Cross Border Insolvency Regulations 2006 be transferred to the Companies Court, Chancery Division, High Court of Justice, solely for the purpose of making the Order contained in paragraphs 2 to 10 below.
