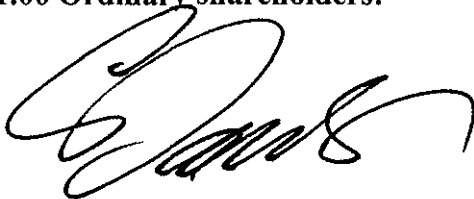
Elective Resolutions
