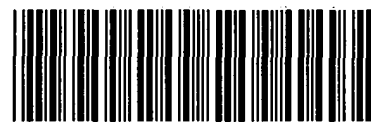

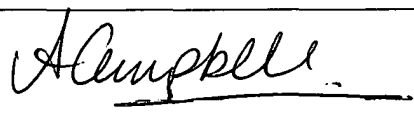

Notify all parties
