# Annual Report and Financial Statements for the period 1 September 2008 – 31 August 2009

**Directors' Report** 

This has been a challenging year of transition for the organisation. Arts Council funding for the core running costs of CreativePeople ended in March 2008. Major changes were made to the organisation from July 2008 onwards, firstly reducing the hours worked by the salaried Director post (not Company Director), Barbara Brunsdon, and then making her redundant in December 2008.

A paid membership scheme was aborted, the website enquiries and careers advice service stopped, and a reduced programme of work continued with freelance support and an increased level of voluntary work by the board of directors

Despite these challenges, CreativePeople pursued activities as a UK network of organisations and individuals involved in continuing professional development in the creative and cultural industries. It ran a membership gathering on 1 April at Cockpit Arts in London on Emerging Technology in CPD and its possibilities, and its national event, CreativeAmbition 3 took place in Birmingham in June 2009 with funding from the Cultural Leadership Programme and in association with AGCAS, the Association of University Careers Advisers.

CreativePeople finished a research programme for Artists Insights, project managed a seminar for freelance trainers and advisers in governance and organisational development (GOLD Net), and managed the Concourse Journey Fund for the Cultural Leadership Programme
