### **DIRECTORS' REPORT**

During the year we were called out to 9 incidents of varying severity, which tested the crew's training and resourcefulness to the extreme. These ranged from helping a boat stuck in mud in the harbour, being on stand by to help dolphins in danger of running to shore to one incident where the crew where able to assist a rescue helicopter locate fishermen in severe waters off Burrowhead. To their credit, although this incident ended in fatalities the crew responded immediately the following day to another shout Those who responded to all callouts did so with a professionalism and dedication, which is to be congratulated.

Whilst the year, from the Lifeboat's 'public' perspective seemed to be relatively quiet much was going on 'behind scenes' with ongoing training and maintenance of all the equipment required to ensure the Lifeboat is always ready to be launched as and when required, whilst not the most 'glamorous' aspect of being a volunteer with the Inshore Rescue Service is an essential ingredient. We have ended the year with some additions to the crew numbers as well as a replacement Land Rover

The tasks ahead for 2007/8 are to continue the training of crew members, as well as recruitment to all aspects of the work required to ensure the smooth running of Port William Inshore Rescue Service.

The Directors would like to thank all who willing give of their time and skills and are confident that the quality of service provided by all the volunteers associated with Port William Inshore Rescue Service to the area will continue to be of the highest standard.
