PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The company aims to promote physical activity in young children, both in the Devon region and across the UK. During the financial year 2018 – 2019, the community has benefited from the following activities:

Monthly Community 'Pop Up' Bike Circuit Sessions have been held in Exmouth. During
the warmer months these were held at LED Outdoor Tennis Centre and in the colder
months, indoors in LED Exmouth Leisure Centre. These LED facilities operate as a charity
therefore the hireage charges payable have benefitted the charity.

Thanks to an Exmouth Community Grant from Exmouth Town Council of £1700 that we bid for during a pitch event in February 2019, we were able to keep the costs down to participating families significantly. We also offered the Action for Children's East Devon branch, 10 free year passes to give to vulnerable families that they worked within the region.

We provide all the equipment to create a safe fun obstacle course as well as trikes, balance bikes, pedal bikes, scooters and helmets for use to allow as many families as possible to join in the action.

We had 183 riders join us during these events.

- Three Community 'Pop Up' Bike events held at Hamlin Lane, Exeter City with 49 riders
 joining in, using our provided equipment or bringing their own.
- Summer Fun in the Sun 'Pop Up' Bike events held at Ocean Drive Space on the Exmouth Esplanade weekly through the 2019 summer holidays. This enhances the provision of physical activity for children down on the Exmouth waterfront and provides both local and visiting children an opportunity to build on their biking skills. We had over 100 riders join us for these.
- Balance Bike Lessons were run at the following schools and kindergardens:

Sidbury Primary School -60 Reception and Year 1 students for a block of 8 weekly visits. These lessons formed part of their Physical Education lessons, building a wider variety of provision to engage more students in the life skill of riding a bike.

St. Peters Preparatory School – 16 Nursery & Reception students followed a 10 week bike skills course.

The Dolphin Pre-School – 20 Nursery students took part in a single morning event.

Balance Bike Lessons were run at the following community locations for 57 riders:

Clyst St Mary Community Hall Littleham Community Hall Littleham Community Leisure Centre

These lessons/sessions help develop key riding skills that will allow children to more safely continue to cycle throughout their lives.

- School Summer Fairs at St. Peters Prep School and Ottery St. Mary Primary School were supported by setting up our 'Pop up' bike circuit at their event to provide an activity to entertain their visitors. Any additional profit was donated to the schools as part of their fundraising efforts.
- In collaboration with Forestry England at Haldon Forest, Haldon, Devon, we ran a pump track event for 25 riders to build skills of managing off road riding. This highlighted this location to parents with young riders as a place for more regular visits.
- We took on a 16 year old part time employee in April 2019 who helped manage the 'pop up' events on the weekends.
- Local activities, outdoor spaces and UK wide initiatives that promote physical activity have been shared and showcased on my Facebook page (670 followers) and Instagram (400 followers) page.
- Blogs written on our website https://whizzkids-toys.co.uk/blog help educate parents of the importance of physical play, provide activity ideas and resources.
- Currated Pinterest Boards hold a growing collection of easy to use resources for parents to promote activity at home with their toddlers.
- Whizz Kids Crew monthly newsletter, sent to 266 subscribers UK wide, highlights a mixture of physical activities for pre-schoolers that can be tried at home as well as other active organisation's work.

At the end of each Balance Bike session, we ask for verbal feedback and improvements that could be made on the session from the customer's perspective.
- Our employees. Feedback is always taken verbally after every event on suggestions for improvements from their perspective.
- The East Devon community. We regularly share our ideas with the East Devon community via Facebook community pages to gauge opinions for future direction. Based on this information, we have adjusted days for events and timings.
