MEMORANDUM OF ASSOCIATION

- 1. The name of the Company is "RIGHT IN YA FACE PRODUCTIONS LTD".
- 2. The Registered Office of the Company will be in England.

COMPANIES HOUSE

- 3. The objects for which the Company is established are:
 - 3.1 to provide equipment, consultancy and services in the UK live events industry;
 - 3.2 to carry on such ancillary business as is required to facilitate the objectives listed in 3.1.
- 4. In support of the objects, but not otherwise, the Company shall have power to do all things incidental or conducive to the attainment of the objects or any of them. In particular (but without limitation) the Company shall have the following powers:
 - 4.1 to pay out of the Company's funds the costs incurred in forming the Company;
 - 4.2 to pay out of the Company's funds premiums on insurance policies to cover the liability of the Directors established by the Articles of Association which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of duty or breach of trust of which they may be guilty in relation to the Company: provided that any such insurance or indemnity shall not extend to any claim arising from criminal neglect or deliberate default on their part;
 - 4.3 to promote any other company for the purpose of acquiring the whole or any part of the business or property or undertaking or any of the liabilities of the Company, or of undertaking any business or operations which may appear likely to assist or benefit the Company;
 - 4.4 to set up, establish, support and maintain superannuation and other funds or schemes (whether contributory or non-contributory) for the benefit of any of the employees of the Company or of any subsidiary, holding or fellow subsidiary of the Company and of their wives, widows, children and other relatives and dependants and to lend money to any such employees or to trustees on their behalf to enable any such schemes to be established or maintained.

- 5. The liability of the members is limited.
- 6. The share capital of the company shall be one hundred pounds. There shall be one hundred shares, each with a par value of one pound. Each share shall have equal voting rights, without prejudice to the companies right to issue non voting shares or additional voting shares at any later time.
- 7. If on the winding up or dissolution of the Company there remains any surplus property after satisfaction of the Company's debts and liabilities, the surplus shall be paid to the members of the Company in proportion to their ownership of shares at that time.
