1 Introduction

- 1.1 I, Andrew Dix (the Liquidatror) of LB Insolvency Solutions Limited (LBIS) Swift House, Ground Floor, 18 Hoffmanns Way, Chelmsford, Essex, CM1 1GU, was appointed as Liquidator of Security Systems Technology Limited (the Company) on 14 September 2017. The affairs of the Company are now fully wound up and this is my final account of the liquidation, which covers the period since my last annual progress report (the Period).
- 1.2 Information about the way that we will use and store personal data on insolvency appointments can be found at www.lbinsolvency.co.uk/privacy-policy/. If you are unable to download this, please contact us and a hard copy will be provided to you.
- 1.3 The trading address of the Company was Curve Office, Suite 13, 30b Wilds Rents, London, SE1 4QG.
- 1.4 The registered office of the Company was changed to C/O LB Insolvency Soutions Limited, Swift House, Ground Floor, 18 Hoffmanns Way, Chelmsford, Essex, CM1 1GU and its registered number is 06627892.

2 Receipts and Payments

2.1 At Appendix A, I have provided an account of my Receipts and Payments for the Period with a comparison to the directors' statement of affairs values, together with a cumulative account since my appointment.

3 Work undertaken by the Liquidator

3.1 This section of the report provides creditors with an overview of the work undertaken in the liquidation since the last annual progress report together with information on the overall outcome of the liquidation.

Administration (including statutory compliance & reporting)

- 3.2 As you may be aware, the Liquidator must comply with certain statutory obligations under the Insolvency Act 1986 and other related legislation. Details about the work I anticipated undertaking in this regard was outlined previously and I would confirm that in this Period there were no matters that affected the final outcome.
- 3.3 Where the costs of statutory compliance work or reporting to creditors exceeded the initial estimate, it will usually be because the duration of the case has taken longer than anticipated, possibly due to protracted asset realisations, which have in turn placed a further statutory reporting requirement on the Liquidator.

As noted in my initial fees estimate/information, this work has not necessarily brought any financial benefit to creditors, but is work required on every case by statute.

Realisation of Assets

3.4 There are no further assets to realise.

Creditors (claims and distributions)

3.5 Further information on the outcome for creditors in this case can be found at section 4 of this report. A liquidator is not only required to deal with correspondence and claims from unsecured creditors, but also those of any secured and preferential creditors of the Company. This may involve separate reporting to any secured creditor and dealing with distributions from asset

- realisations caught under their security, most typically a debenture as well as dealing with the general handling of communications with stakeholders, such as customers and suppliers.
- 3.6 Claims from preferential creditors typically involve employee claims and payments made on behalf of the Company by the Redundancy Payments Service following dismissal.
- 3.7 The above work will not necessarily bring any financial benefit to creditors generally and the more creditors there are on an assignment, the higher the resultant cost will usually be. However, a liquidator is required by statute to undertake this work.

[nvestigations]

- 3.8 Some of the work the Liquidator was required to undertake was to comply with legislation such as the Company Directors' Disqualification Act 1986 (CDDA 1986) and Statement of Insolvency Practice 2 Investigations by Office Holders in Administration and Insolvent Liquidations and may not necessarily bring any financial benefit to creditors, unless those investigations revealed potential asset recoveries that could have been pursued for the benefit of creditors.
- 3.9 My report on the conduct of the Directors of the Company to the Department for Business, Energy & Industrial Strategy under the CDDA 1986 was submitted in accordance with statutory timescales and is confidential.
- 3.10 Since my appointment, I would advise that no further asset realisations have come to light that may be pursued by me for the benefit of creditors.

Unsecured Creditors

- 3.11 I received claims totalling £160,825.54 from six creditors, the remaining 15 creditors did not submit their claims.
- 3.12 I can confirm that the realisations in the liquidation are insufficient to declare a dividend to the unsecured creditors after defraying the expenses of the proceedings.

4 Liquidator's Remuneration & Expenses

- 4.1 The basis of the Liquidator's remuneration was fixed by reference to time properly spent by me and my staff in managing the liquidation.
- 4.2 My time costs for the Period are £3,590.00. This represents 16.10 hours at an average rate of £222.98 per hour. Attached as Appendix B is a Time Analysis which provides details of the activity costs incurred by staff grade during the Period in respect of the costs fixed by reference to time properly spent by me in managing the liquidation.
- 4.3 A narrative explanation of the work undertaken by the Liquidator during the Period can be found at section 3 of this report and I would confirm that £2,654.98 plus disbursements of £171.34 has been drawn during the Period on account of my accrued time costs.
- 4.4 I would confirm that £2,654.98 has been drawn against my total time costs since my appointment and that no further amounts will be drawn in the liquidation.
- Also attached as Appendix C is a cumulative Time Analysis for the period from 14 September 2017 to 8 November 2019 which provides details of my time costs since the commencement of the liquidation. These time costs total £12,657.50 which represents 70.45 hours at an average rate of £179.67 per hour.
- 4.6 Attached as Appendix D is additional information in relation to the Liquidator's fees and the expenses and disbursements incurred in the liquidation.
