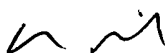

Notes to the Abbreviated Accounts For the year ended 30 June 2015

1. Accounting policies

The financial statements are prepared in accordance with applicable United Kingdom accounting standards. The particular accounting policies adopted are described below and have been applied consistently throughout the current financial period.

Accounting convention

The financial statements are prepared under the historical cost convention.

Cash flow statement

The Company has taken advantage of the exemption in Financial Reporting Standard No.1 (Revised 1996) from the requirement to produce a cash flow statement on the grounds that it is a subsidiary undertaking where 90 per cent or more of the voting rights are controlled within the Group.

Basis of preparation

The accounts have been prepared on the basis the Company is a going concern.

As the Company did not trade in the period no profit and loss account has been included in these financial statements.

2. Ultimate parent undertaking

The ultimate parent undertaking and controlling party during the reporting period was Renewable Energy Generation Limited, a company incorporated in Jersey. The Registered Office of the ultimate parent undertaking was Elizabeth House, 9 Castle Street, St Helier, Jersey, JE4 2QP. This was the largest and smallest group which prepares consolidated financial statements including the Company.

After the balance sheet date, Whittlesey Limited was sold as part of a wider transaction to RI Income UK Holdings Limited. The ultimate parent undertaking in this group is considered to be Blackrock Infrastructure Funds Public Limited Company, an investment company registered in Ireland which accounts for investments at fair value and does not prepare consolidated financial statements. Refer to note 3 for further information on the transaction.

The immediate parent company changed on the same date to RI Income UK Holdings Limited, a company registered in England & Wales, of which Whittlesey Limited is a wholly owned subsidiary. The financial statements of RI Income UK Holdings Limited are available from their registered office at 12 Throgmorton Avenue, London, EC2N 2DL.

3. Post balance sheet events

On 26 October 2015, the Company name was changed from REG Cholwich Town Limited to Whittlesey Limited

On 1 December 2015, the Company acquired a 1.8MW wind farm from REG Windpower Limited for consideration of £3,750,000. It was funded through an intercompany loan.

On 21 December 2015, Renewable Energy Generation Limited sold Whittlesey Limited as part of a wider transaction to RI Income UK Holdings Limited. New directors were appointed on the date of the transaction.

RI Income UK Holdings Limited, will function in the same manner as Renewable Energy Generation Limited and as such there will be no fundamental change to the way the Whittlesey Limited is managed or operated.
