than to take the necessary steps to:

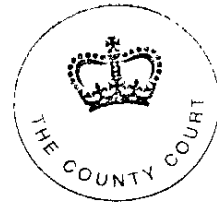
- (I) realise monies from its bank account referred to in paragraph 8

IT IS ORDERED THAT:

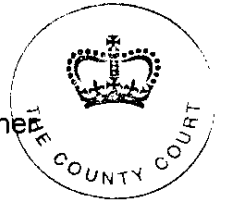
(1) the name of the above named Rickmansworth Homes and Lettings Limited be restored to the Register of Companies
