**Accounting convention**

**Turnover**

Turnover represents net invoiced sales of goods, excluding value added tax.

**Goodwill**

There is no amortisation on goodwill as the director considers its residual value exceeds the balance sheet value.

**Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

**Deferred tax**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
