TRUSTEES REPORT FOR THE YEAR ENDED 31 DECEMBER 2015

CONSTITUTION

The Company limited by guarantee was formed on 16 February 2010 and is governed by its Memorandum and Articles of Association. The Company was registered as a charity in November 2013 and took over the operation of a church established under a Bishop's Mission Order on 1 January 2014.

AIMS AND OBJECTIVES

The Company is a fresh expression of church ministering in the Anglican tradition to young people who are in secondary education in north Bradford, complementing the youth ministries in six ecclesiastical parishes within the Bradford Area of the Diocese of West Yorkshire and the Dales.

LEGAL STRUCTURE

The Company is managed by its trustee/directors who are members of the company. The day to day management is delegated to a Church Council comprising ex-officio and elected members, In the vent of a winding up each member of the Company must contribute £1 to any deficit.

ACTIVITIES AND ACHIEVEMENTS

Sorted continues to work in Immanuel College and Hanson Academy providing lunchtime clubs and detached youth work in conjunction with the staff of both schools.

Sorted also operates through 3 distinct groups; youth congregations in BD2 and BD10 that each meet three times per week for social activities, learning through discussion and a worship service. The third congregation is made up of young adults who meet in small groups to learn and explore Christian faith and also meet to socialise.

Members of the whole group also took part in a summer camp at Sneaton Castle, the home of the sisters of the Order of the Holy Paraclete, in Whitby.

Sorted work with up to 150 young people or young adults per week and have contact with many other schools.

Sorted is hosting its first conference in May to help others wanting to do work with fresh expressions of church or youth work learn from its experiences.

Andy is working with SCM publishers to release a book that will enable others to learn from Sorted experience of both pioneering fresh expressions of church and youth work.

Work has begun on securing funding streams to finance the activity for the foreseeable future. A grant from Garfield Weston has enabled the church to engage Olive Branch Trust to assist this work.

Sorted appreciates the support of donors which in addition to Church Army and the Diocese include St James Church, Bolton Villas URC, Church Urban Fund, Lord Barnby Trust, James Archer Trust, Henry Smith Charity, Liz & Terry Bramall Foundation, Souter Trust, Grace Dieu Trust, Tesco Charity, George A Moore Charitable Trust and a number of individual benefactors.

FINANCIAL REVIEW

In addition to the activity reported in the Financial Statements the stipend and housing costs of the Project Leader are funded by Church Army and the Diocese of West Yorkshire and the Dales, respectively.

The gift income of members has been paid to the Diocesan Board of Finance as a contribution to the Diocesan Share.

The state of reserves is considered sufficient for current needs.

RESERVES POLICY

A reserves policy is to be agreed once a level of activity is established and income streams are secured.

RISK MANAGEMENT

The board and Church Council have identified the major risks and keep their mitigation policy under regular review.

PLANS FOR THE FUTURE

Work continues to secure new streams of funding to replace that received through Church Army, the current commitment to which runs to at least 2017.

STATEMENT OF THE TRUSTEES' RESPONSIBILITIES

SORTED CHURCH NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2015

1 Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

Basis of accounting

The financial statements are prepared under the historical cost convention on a going concern basis and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Statement of Recommended Practice 'Accounting and Reporting by Charities' issued in March 2005 (SORP 2005) and the Companies Act.

Fixed Assets

Equipment costing less than £1,000 is written off on acquisition.

Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of grants, donations and gifts and is included in full in the statement of financial activities when receivable.

The value of services provided by volunteers has not been included.

Grants, including grants for the purchase of fixed assets, are recognised in full in the statement of financial activities in the year in which they are receivable.

Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be recovered, and is reported as part of the expenditure to which it relates.

2. Related Party Transactions

The activity is supported by Church Army (a registered charity) and the Diocese of West Yorkshire and the Dales.

Church Army provides the stipend of Capt James Hawksworth (2104 3) and provides housing for Capt Hawksworth (2014 2). Church Army also pays a full stipend to Capt Andy and half a stipend to Revd Tracy Milne, the Diocese provides their housing.

Church army pays all staff expenses.

These transactions are not reflected in the Financial Statements

3. Restricted Funds continued

Camp and holidays fund represents grants received and surplus income for annual residential events.

Equipment represents grants received for the purchase of equipment for which no contracted obligation existed at the year end.

Rent is the funding received for the payment of room hire costs.

Thrive is a programme of ministry to young parents, including some that have previously been active in Sorted Church and are now moving to an independent living and family life. The project is partly funded by an annual grant to Sorted Church. The fund represents unspent grant which is committed to meeting employment costs of the Thrive worker.

Stipends represents grants received to fund contributions required by Church Army as their commitment to funding reduces.

Other costs represents grant funding for support costs of the project.

Development/fundraising represents grant funding to defray the costs of obtaining funding commitments to secure the future activity.
