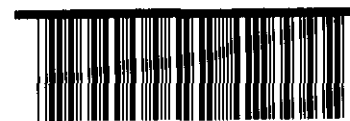

TO THE MEMBERS OF SUMMERHILL VILLAS LIMITED


We have examined, without carrying out an audit, the Accounts for the year ended 31st January 2000 set out on Pages 4 to 7.
