1 Statutory information

Swansea Hydraulics Limited is a private company, limited by shares, registered in England and Wales, registration number 02774045. The registered office is Heol Groeswen, Treforest Industrial Estate, Pontypridd, CF37 5YF.

2 Compliance with accounting standards
