TRUSTEES' REPORT FOR THE YEAR ENDED 31 MARCH 2006

The trustees present their report and accounts for the year ended 31 March 2006.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's governing document, the Companies Act 1985 and the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005.

Structure, governance and management

The charity is a company limited by guarantee. None of the trustees has any beneficial interest in the company. All of the trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

Trustees meet formally to manage affairs, with a least one Trustee on site. The Museum is managed by an Administrator and a Project Manager (Chair of the Trust).

The trustees have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

TRUSTEES' REPORT (CONTINUED) FOR THE YEAR ENDED 31 MARCH 2006

Objectives and activities

The Charity's object and its principal activity, is to educate and to promote, the education of the public in the history, traditions and practices, of the Fishing Community of Brighton, including the collection and public display, of fishing artefacts and other materials, relevant to the history of fishing in Brighton.

The Brighton Fishing Museum is supported by Brighton and Hove Council and Volunteer Workers.

The Museum is open to the public free of charge and attracts over 150,000 visitors per year. The Museum also has the free use from the Brighton Fishing Quarter of a Gallery, Workshops and frontage, used for the repair and conservation, of traditional Sussex fishing boats.

Museum volunteers are available to guide school parties and other groups around the museum and fishing quarter, or give illustrated talks on fishing history.

An Archive of the Brighton and Sussex Sea Fishing Industry and Communities, is open to scholars and to the public by appointment.

Achievements and performance

The Fishing Museum this year has attracted similar if not more visitors than previous years.

The Fishing Museum has gained 21 year a rent-free lease for Arches 200 and 201 from the Fishing Quarter. Arch 200 of the Museum was completely gutted, rewired, fire and burglar alarms replaced or resituated, ceilings put in place, the whole Arch redecorated and a temporary West Pier exhibition has been installed up and until the end 2008. The Museum displays have all been digitized thanks to the University of Brighton and new equipment purchased and installed.

The Fishing Museum Trust as indicated in last year's review is now only responsible for the heritage assets, i.e. artefacts etc. in its premises (Arches 200 and 201) and on 1 April 2005 transferred the capital equipment, such as tools and equipment that will have to be replaced at some considerable expense in the Fishing Quarter Gallery and Workshops, to the Fishing Quarter Trust. The Fishing Quarter Trust (as also indicated in last year's review) has now relieved the Fishing Museum and is now responsible for all the revenue costs incurred in maintaining the fabric of Fishing Quarter and most importantly the Fishing Museum itself. In consequence contributions to the Fishing Museum now only fund day-to-day expenses e.g. insurance, phone, electric, and is beginning to accumulate a financial reserve for the Fishing Museum, with no calls on it by the Fishing Quarter.

Financial review

The Statement of Financial Activities shows a net reduction in funds for the year of £9,657, and the reserves stand at £54,636.

The present level of funding is adequate to support the charity's objects, and the trustees consider the financial position of the charity to be satisfactory.

Plans for the future

The top of Arch 200 will be cleared and turned into a Museum store, which is a registration requirement. The ramps allowing disabled access around the Fishing Museum will be renewed and a further ramp installed between Arches 200 and 201. The Fishing Museum will be professionally cleaned once a week the cost to be met by the Fishing Quarter.

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2006

1 Accounting policies

1.1 Basis of preparation

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and the Companies Act 1985.

1.2 Incoming resources

Donations and other income are included in the company's accounts when received. In addition donations and voluntary assistance are received in kind and it is not practical to quantify their value and reflect this in the accounts.

The charity accounts for all voluntary cash on a receipts basis being the point at which it is entered into the charity's books. The Brighton Fishing Museum depends on assistance from Statutory Bodies, Charitable Bodies and Individuals in order to carry out its work in the community. The trustees have planned fund raising activities to fund both the development and ongoing day to day operation of the Museum. Subject to continued support the trustees believe that the Museum will continue to fulfill its community objectives.

1.3 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:

Fixtures, fittings & equipment

20 years straight line

The Museum's heritage assets are not depreciated, because their useful life is considered to be very long, and are revalued by the trustees annually, to account for movements caused by donations, repairs and removals. This is a change in acounting policy from the previous year, as reflected in the Trustee's Report.

1.4 Stock

Stock is valued at the lower of cost and net realisable value.
