1 Accounting Policies

Basis of measurement and preparation of accounts

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective January 2015.

The company has net liabilities amounting to £3,596 (2015 - £4,548) at the balance sheet date. However, day to day working capital requirements are met through a bank overdraft facility subject to annual review and by funds generated through current trading. In view of these arrangements the director considers that the company's financial statements are properly drawn up on the basis of a going concern.

Turnover policy

Turnover comprises the invoiced value of goods and services provided by the company, net of value added tax.

Tangible assets depreciation policy

Depreciation has been provided at the following rates in order to write off the assets over their estimated useful lives:
