
**PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT**

In the space provided below, please insert a general account of the company's activities in the financial year to which the report relates, including a description of how they have benefited the community.

During the respective financial year (2018-2019), The Aspiring Medic's Support continued to expand activities in order to forward its mission of providing support to medical school applicants and medical students from a socioeconomically disadvantaged background.

Various members of the community, particularly those based in London, have benefited from our services in several ways, including:


- Free career workshops- The Aspiring Medic's Support developed a variety of borough-wide workshops for students in the city of London. Within this financial year, the company worked with over 8 schools to run two workshops for the London boroughs of Enfield and Leyton. These workshops were free-of-charge for all local students (aged 15-18 years old) and provided them with the opportunity to learn more about the application process for medical school and other healthcare professions.
- Free teacher training- During this year, The Aspiring Medic's Support worked with Leyton Sixth Form College to provide a free teacher training course for teachers in state schools. These teachers, who were less equipped to support their more academic students as compared with private school counterparts, were taken through a teaching session to explore how they may best support their students. This session was also delivered at no charge to the school or teachers, thus promoting a reduction in the education inequalities that exist within the profession.
- Mentoring- During this financial year, 3 sixth-form students received free intensive coaching to assist them with their medical school application process. This programme included application review, interview coaching or academic mentoring to help better equip them to pursue their chosen career paths. Two of these students have gone to successfully acquire places at medical school and are now furthering their studies.
- Free resources for medical students- The Aspiring Medic's Support also benefited medical students from a socioeconomically disadvantaged background during this period through the provision of free teaching resources. Five medical students were supported during this financial year in their academic pursuits, through the provision of regular mentoring and teaching resources to aid their career progression.
- Political advocacy- students from a socioeconomically disadvantaged background who were in school at the time also benefited from our work in political advocacy. We lobbied local MPs, universities and other sector stakeholders to raise awareness of the underrepresentation of socioeconomically disadvantaged students. Joan Ryan, former MP for Enfield North, formally endorsed this campaign, which served in ensuring these students in question were seen and heard.

The company's stakeholders include students from a socioeconomically disadvantaged background (both aspiring and current medical students), the parents of these students as well as their teachers.


We have consistently taken various steps to ensure that these stakeholders are regularly consulted, and any given feedback is swiftly acted upon.

Prior to the two mentioned career workshops in Enfield and Leyton, The Aspiring Medic's Support hosted two other borough-wide workshops for both Lewisham and Hackney in 2017- prior to formal establishment. In both of these events, written feedback was taken from students in questionnaires to learn how the workshops could be more tailored and beneficial in the future. All suggestions were recorded and subsequently implemented for the career workshops that occurred during the financial year in question. Additionally, feedback was also taken from students in both workshops in the financial year (2018-2019) and subsequent events that have since been developed during this current financial year have implemented all suggestions from this group of stakeholders.

Parents of students have also been regularly consulted during the financial year in question. Parental consent was taken from the parents of students who have been formally mentored within the mentoring programme. These opportunities were also used as a time to consult with parents concerning how the mentoring programme can also benefit them or improved to better support their children. Consequently, we have used their feedback to ensure that the mentoring programme continues to include and educate parents concerning how they may support their children during the application process for university.

Finally, teachers have been consulted in a number of ways. At each careers workshop, written feedback has consistently been obtained from teachers to learn how the event can be of more benefit both to the teachers and students in question. Teacher feedback is partly the reason why we went on to develop the teacher training course. Feedback was also taken from teachers at Leyton sixth form college to help develop a more sustainable and scalable course for teachers in other state schools.




