PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The Company has carried out activities with the intention of benefiting and engaging with the local community and in particular (without limitation) through the delivery of performances, production and promotion of artistic work and events in the disciplines of dance, theatre and performance art for, and within, communities.

The projects carried out in 2018 include the continued running of weekly Tuesday Afternoon Tea Dances now at Dreamland, Dreamland Tea Dances (once every 3 months), created / published I Mambo Margate Community dance participation film (now online via youtube). We produced a heritage theatre project with community participation commissioned by Margate Pride & Margate Festival, performed in Sept 2018. The company has raised funds via Thanet Council, Arts Council, Heritage Lottery, Awards for All, Kent County Council to deliver further projects across 2017 to 2018.

All projects above have engaged and collaborated with local communities who have participated as audience members and as participants dancing at events. The events have been intergenerational with a focus on those who are 50+. Benefits to this age group are both physical, via the gentle exercise of social dance, and mentally from regular social contact which challenges isolation, social exclusion and alienation.

We are now pursuing further funding via ACE / Community Fund and KCC. We will be commissioned for a new artist work in 2019 / 20 called Collision Dance & Light Show.

PART 2 - CONSULTATION WITH STAKEHOLDERS

Stakeholders include company Directors, dance teachers, dance hosts, performers and community participants who attend social dance events, participate in projects or attend as audiences for performances.

Anna Symes, the artistic director is the main host at the company dance events which provide regular contact with the community - which events and performances are designed to benefit. This means that she regularly checks in with participants to take on feedback and continually adapts the work and events to the needs of the community. Feed back forms were last completed Autumn 2018 for Tea Dances.

After every performance piece, feedback forms are handed to the audiences to collect data and feedback to continually improve and develop work. The key principles on which events and artistic performance are developed include reaching non-traditional arts audiences, events should be culturally enriching with a focus on inclusivity.

Contact with audience and participants is maintained via social media updates, pages for the company and its projects and via regular emails to the mailing list. Print publicity is distributed.

Regular meetings are held with collaborators (dance teachers, hosts, performers) who are working on events and performances in the run up to project delivery.

Directors meet on a regular basis to discuss company strategy and Anna Symes is able to report back to Directors on feedback and information around community participants. Future projects have been planned carefully taking on board needs of the participants and the needs of Margate which is trying to flourish again following a period of extreme deprivation. The work is striving to support well being for the town and it's community, many new projects are being delivered 2019 / 20, these are built on the intensive community participation that has been building since
