- For the last financial year Reach Out for Mental Health (ROFMH) has been operating a
 befriending service supporting individuals who are feeling suicidal or feel they are
 approaching a point of crisis.
- We have supported around 30 people either face to face in one of our community hubs, over the phone or by text with feelings of hopelessness, worthlessness and overwhelming exhaustion.
- We cover the entire borough of Thurrock and have accepted referrals from GP's, Local Area Coordinators, Care Coordinators, Social Workers and self-referrals.
- We have also trained around 20 gatekeepers in suicide prevention thereby providing them with the techniques and confidence in how best to identify someone who is suicidal, who may be at high risk of suicide and how to support someone who is suicidal.
- We have advertised our service and worked to reduce the stigma around suicide on regional radio, local fundraising events, have been asked to appear at a number of conferences and provide workshops in suicide prevention
