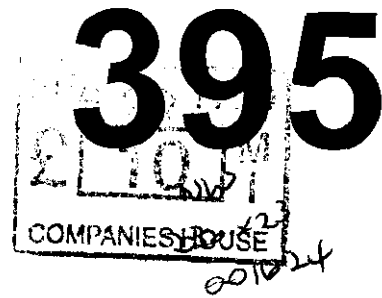



1.
