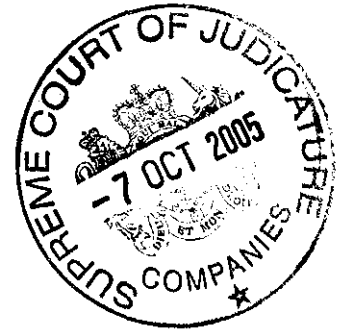

AND UPON READING the evidence

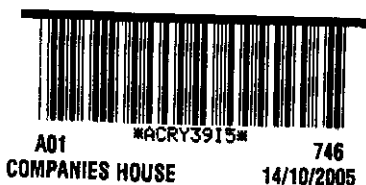


AND IT APPEARING that there is no opposition on behalf of Her to the

AND the Claimant by his Solicitors undertaking:

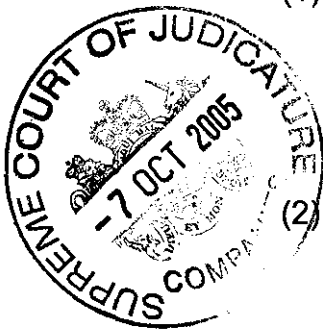

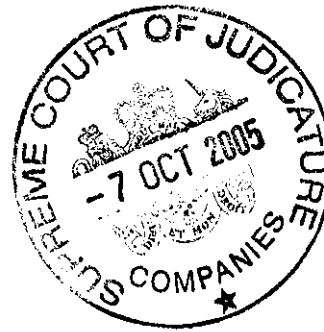
