The total amount of operating lease commitments not included in the balance sheet is £76,470 (2018 - £75,443). This balance is made up of non-cancellable operating leases in relation to land, buildings and equipment. £33,062 (2018 - £23,087) of the total balance expires not later than one year. £43,408 (2018 - £52,356) of the total balance expires later than one year, but not later than five years.

These financial statements have been prepared in accordance with the micro-entity provisions of Regulation 12 of the Limited Liability Partnerships (Accounts and Audit) (Application of Companies Act 2006) Regulations 2008 (SI 2008/1911) and delivered in accordance with the provisions applicable to companies subject to the small companies regime, as applied to limited liability partnerships.

For the year ending 31 March 2019 the limited liability partnership was entitled to exemption from audit under section 477 of the Companies Act 2006, as applied to limited liability partnerships, relating to small entities.


