VCS (Wayzgoose) Limited, VCS (Clearpoint) Limited and Abbotts Creative Print Limited - In Administration ("the Companies")

This letter constitutes our final report in respect of the Administration of each of the Companies.

1 Statutory Information

- The Joint Administrators are Toby Scott Underwood and Francis Graham Newton of BDO LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5RU. The appointment as Administrators for VCS (Wayzgoose) Limited ("Wayzgoose") and VCS (Clearpoint) Limited ("Clearpoint") took place on 15 September 2008 and for Abbotts Creative Print Limited ("Abbotts") took place on 22 September 2008 Under the provisions of Paragraph 100 (2) of Schedule B1 to the Insolvency Act 1986 the Administrators carry out their functions jointly and severally and either Administrator has exclusive power to exercise any function
- The Joint Administrators were appointed by the Companies' Directors, pursuant to Paragraph 22 of Schedule B1 to the Insolvency Act 1986 The Administration proceedings are dealt with in the Leeds District Registry Chancery Division and the court case numbers are 1315, 1316 and 1314 of 2008 for Wayzgoose, Clearpoint and Abbotts respectively
- 1.3 The Companies' registered offices are situated at BDO LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5RU and the registered numbers are 01284489, 02273728 and 00627236 respectively
- We enclose, for your information, a summary of our receipts and payments to date, together with a copy of our abstract receipts and payments account

2 Receipts

The receipts shown are largely self-explanatory, although we would comment specifically on





2 1 Book Debts

- 2 1 1 A specialist collection agent, Legal and Receivables Limited trading as Largo ("Largo"), was instructed to collect the book debts of Wayzgoose and Clearpoint. Abbotts' book debts were collected directly by the purchaser of the business and assets of Abbotts. TWRM Print Limited ("TWRM") Largo was subsequently instructed to collect the residual ledger
- 2 1 2 To date, amounts of £1m, £137k and £412k have been realised in Wayzgoose, Clearpoint and Abbotts respectively
- 2 1 3 All debtor receipts have been banked directly to the GE Commercial Finance Limited ("GE") invoice discounting facility bank account

GE held a fixed charge over book debts The outstanding liability due to them at the date of our appointment, totalling £1 354m, has been repaid in full Whilst a surplus was received after repaying GE under its fixed charge, it was insufficient to repay professional costs in full, including those of the Joint Administrators

22 Freehold Land and Property (East Road, Sleaford)

- 2 2 1 The property was sold for £680k on 19 January 2009 with funds being received in full upon completion
- 2 2 2 A distribution of £588k was made to HSBC Bank Plc ("HSBC") under its fixed charge security in respect of this property

23 Sale of Business and Assets of Abbotts

2 3.1 The sale of Abbotts' business and assets to TWRM completed on the day of our appointment Consideration totalling £80k has been received, allocated as follows

24 Other Asset Realisations in Wayzgoose and Clearpoint

- 2 4 1 Edward Symmons LLP was instructed to realise the remaining assets of Wayzgoose and Clearpoint These consisted of residual plant and machinery, motor vehicles and fixtures and fittings Realisations in this respect totalled £15k and £13k in Wayzgoose and Clearpoint respectively
- 2 4 2 Larger items of plant and machinery subject to finance agreements were collected by the relevant finance companies following our appointment. Our agents confirmed there was no equity in these items.
- 2 4 3 We have successfully realised £56k from HM Revenue and Customs in respect of a Corporation Tax terminal loss relief claim.

3 Extension of Administrations

- 3 1 Under the provisions of Schedule B1 to the Insolvency Act 1986 the Administrations would have automatically ended on 14 September 2009 (Wayzgoose and Clearpoint) and on 21 September 2009 (Abbotts) being twelve months from commencement
- HSBC and GE approved the extension of each Administration, in their capacity as secured creditors, until 14 March 2010 (Wayzgoose and Clearpoint) and 21 March 2010 (Abbotts) Such extensions were made pursuant to paragraph 76(2)(b) of Schedule B1 to the Insolvency Act 1986 on 10 August 2009 The extensions were required to enable realisation of remaining assets

4 Future of the Administration

We have continued to manage the business, affairs and property of the Companies in line with the proposals approved by creditors pursuant to Rule 2 33(5) of the Insolvency Act 1986 The Administrations are now complete. The Administrations will end once form 2 35B is filed with the Registrar of Companies and the Court. The Companies will automatically be dissolved three months after the registration of form 2 35B at the Registrar of Companies.

5 Prospects for Creditors

- Under the provisions of Section 176A of the Insolvency Act 1986 the Joint Administrators must state the amount of funds available to unsecured creditors in respect of the prescribed part
- There will be insufficient realisations to enable any dividend to be made to unsecured creditors under the prescribed part



5 3 Secured Creditors

- 5 3 1 HSBC held a legal mortgage charge dated 17 May 2007 over the freehold property at Sleaford Amounts due to HSBC at the date of our appointment were approximately £767k and £98k in respect of a loan and overdraft facility respectively
- 5 3 2 A distribution of £588k has been made to HSBC under its security
- 5 3 3 There have been insufficient funds to enable further distribution to HSBC in respect of the outstanding balance of £277k due under its floating charge security
- 5 3 4 GE has a fixed and floating charge dated 17 May 2007 over the Companies Additional fixed and floating charges dated 23 June 2006, 19 August 2005 and 4 August 1999 are held in respect of Wayzgoose and Clearpoint.
- 5 3 5 GE's lending has been repaid in full

54 Preferential Creditors

- 5 4.1 Preferential creditors' claims represent arrears of pay and outstanding holiday pay due to employees at the date of our appointment Preferential claims of approximately £44k and £23k have been received in Wayzgoose and Clearpoint respectively
- 5 4 2 The going concern sale of Abbotts resulted in no preferential claims arising as all employees were transferred to TWRM under Transfer of Undertakings (Protection of Employment) Regulations
- 5 4 3 Insufficient funds have been realised to pay any dividend to preferential creditors

5 5 Unsecured Creditors

5 5 1 To date we have received claims from unsecured creditors in the sum of £422k, £280k and £352k for each of the Companies respectively. As previously advised, there are insufficient funds to enable the payment of any dividend to unsecured creditors.

6 Administrators' Remuneration

- We attach a schedule which summarises our time costs accrued in dealing with each Administration and indicates the work undertaken in that respect. Pursuant to Rule 2 106 of the Insolvency Rules 1986, the secured creditors GE and HSBC have approved our fees on a time cost basis.
- 62 Joint Administrators' time costs to date for the Administration's totals £168,218

IBDO

- A fee cap of £20,000 plus VAT has been agreed with HSBC in respect of time specifically incurred in dealing with the freehold land and property at Sleaford. However, only £16,170 plus VAT of these agreed time costs have been drawn due to insufficient funds
- Time costs of £57,270, £7,768 and £80,588 plus VAT have been drawn to date in Wayzgoose, Clearpoint and Abbotts respectively I attach a summary of these time costs in accordance with Statement of Insolvency Practice 9 for your information

65 **Disbursements**

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. We therefore report that the sum of £3,680, £866 and £900 respectively has been incurred and drawn in respect of category 1 disbursements. Such disbursements are detailed below.

Summary of Administrators' Proposals

Our proposals, approved by creditors pursuant to Rule 2.33 (5) of the Insolvency Rules 1986 stated that

- (a) The Administrators continue to manage the affairs of the Companies and realise assets in accordance with objective 2 of the statutory purpose for the Administrations, being a better result to creditors compared with liquidation, and,
- (b) Should it be required the Companies exit the Administrations by way of Creditors' Voluntary Liquidation, Francis Graham Newton and Toby Scott Underwood be appointed Joint Liquidators and they will act with joint and several liability,
- (c) Should realisations be insufficient to enable a dividend to be paid to non preferential creditors the Joint Administrators propose to exit the Administrations by way of dissolution of the Companies any under Paragraph 84 of Schedule B1 of the Insolvency Act 1986,
- (d) The Administrators' remuneration be approved on the basis of time properly spent attending to matters arising in the Administrations, such approval to be sought from the secured creditors,
- (e) The Administrators petition for the compulsory winding up of the Companies should the Joint Administrators conclude that additional investigations into the affairs of the Companies is necessary, but that there are insufficient funds available to fund such investigations,
- (f) The Joint Administrators of the Companies be discharged from liability, pursuant to Paragraph 98 of Schedule B1 of the Insolvency Act 1986, in respect of any action of each or both of them as Joint Administrators immediately upon filing their final report and sending it to creditors,
- (g) Should a dividend be paid to unsecured creditors during the Administration, then any unclaimed dividends will be paid to the Insolvency Services Account
