

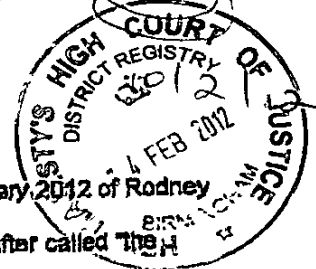

- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"


(6) the Claimant Rodney Snare do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
