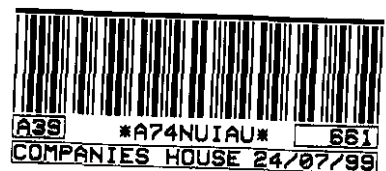

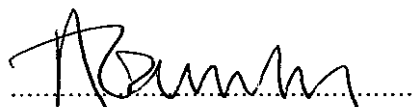

1 **Ownership**
