### Notes to the statement of affairs as at 6 May 2011

- 1 The statement of affairs ignores the costs of insolvency
- 2 It is anticipated that Section 176A of the Insolvency Act 1986 (the prescribed part) will not apply in this case as although there are floating charges created after 15 September 2003, it is anticipated that the net property (after payment of costs of realisation of assets) would be less than £10,000 and the costs of distributing the same will be disproportionate to the benefit
- 3 The company ownes a static caravan, which is subject to a finance agreement The directors have been advised that there are resale restrictions in respect of the caravan. The matter will be considered further by the liquidator in due course.
- The estimated to realise figure for the book debts has been calculated after known doubtful debts have been provided for and a general provision has been made
- The amount due to RBS Invoice Finance Ltd in respect of the invoice finance agreement has not been quantified at this stage, addition charges and fees relating to the closure of the account are anticipated. However it is anticipated that RBSIF will be paid in full from debtor collections
- The cash in hands of accountants is monies held in the Redman Nichols Butler client account being £484 collected from customers of the company not subject to invoice financing and £2,280 realised by the sale of the company's equipment, tools, office furniture and two computers
- 7 The motor vehicle has been valued by Gilbert Baitson, auctioneeers and valuers of Hull
- The inclusion of creditor balances on the statement of affairs is as per the company's records. Claims of creditors will be subject to admission by the duly appointed liquidator in the usual way.
