Notes to the Abbreviated Accounts for the period ended 30 April 2014**1 Accounting Policies****Basis of measurement and preparation of accounts**

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

Turnover policy

Turnover comprises the invoiced value of goods and services supplied by the company, stated net of value added tax and trade discounts.

Tangible assets depreciation policy

Tangible fixed assets and depreciation.

Tangible fixed assets are stated at cost or valuation less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of tangible fixed assets, less their estimated residual value over their expected useful lives on the following bases:

Freehold land - no depreciation

Freehold buildings - 2% per annum on cost

Plant & machinery - 25% per annum, reducing balance basis

Intangible assets amortisation policy

Goodwill

Goodwill is stated at cost or valuation less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of the goodwill over its expected useful economic life which is expected to be 20 years.

Other accounting policies

Consolidation

The company is exempt from the requirement to prepare consolidated financial statements under Section 399(1) of the Companies Act 2006 on the grounds that the company and its subsidiaries are a small group.

Stocks

Stocks have been valued at the lower of cost and net realisable value.

Deferred taxation

Deferred taxation is provided on the liability method to take account of timing differences between the treatment of certain items for accounts purposes and their treatment for tax purposes. Tax deferred or accelerated is accounted for in respect of all material timing differences.

The above subsidiary companies remained dormant during the year. They held legal title to various real estate properties beneficially owned by the company and all the related transactions are reflected in the company's accounts.

The company is a 50% partner in World of Dry Cleaning LLP which makes up its accounts to 30 June. In the period ended 30 June 2013 the LLP made a profit of £18,189 (2012: £31,935) and the Members' Interests were £4,087 (2012: £3,082). This LLP acquired the rights to run the dry cleaning business at Wembley as from 1 July 2010 which formerly belonged to this company. The other 50% partner is one of the immediate family of this company's directors.
