BACKCHAT Theatre Company - registered Charity no. 1052051 (For the year ending 30th June 2000)

This year was extremely disappointing for the Company. None of the funding applications for the proposed French Project was successful, although the Arts Council awarded the Company a grant for the translation of *The Queen of Arles* by Annie Corbier. The main reason for the lack of funding appears to have stemmed from the fact that the assurances of financial support for the project, unofficially received by Annie Corbier from the French Institute, proved to be unfounded. Other funding organisations approached felt that the project was too ambitious to attract funding without the endorsement of the French Institute. This was also the reason for a reluctance by marketing Companies to take on the project which they felt was, in itself, exciting and well-presented. The agents for Annie Corbier and Nikos Dionysios liaised with BackChat in an attempt to save the project but, after several months, it was reluctantly agreed that the production should be abandoned. The accompanying art exhibitions were also cancelled.

It was felt by the Directors that the Company needed time to re-coup energies and to re-think production strategies.

It was agreed that a new adaptation of *Turcaret* as the basis for a possible musical production should be explored, in co-operation with another Company/venue and young people's theatre groups. Projects for readings and other events should begin again in the Spring of 2001.

Application should be made to the Inland Revenue for a refund of National Insurance contributions to actors for the production of *The Marriage of Mr. Mississippi*.
