Each share is entitled to a dividend apportioned and paid pro-rata according to the amounts paid up on the share during any portion of the period in respect of which the dividend is paid. Each share is entitled pari passu to participate in a distribution arising from a winding up of the company. Any share may be issued which is to be redeemed, or is liable to be redeemed at the option of the company or the holder. The board may determine the terms, conditions and manner of redemption on any redeemable shares so issued. There are currently no redeemable shares in issue.
