All moneys from time to time due and owing, whether actually or contingently, by the Company to the Owner (as defined below) under the Lease (as defined below) and the other Lessee Documents (as defined below) (the "Secured Indebtedness").

"Lease" means a lease agreement dated 30 March 2000 between Royal Bank of Scotland (Industrial Leasing) Limited (the "Original Owner") and the Company as novated and amended by a novation agreement dated 18 June 2001 between, among others, the Original Owner, the Owner and the Company (the "Novation Agreement") to be a lease agreement between the Owner and the Company.

"Lessee Documents" means the Lease, the Aircraft Sale and Purchase Agreement, the Assignment of Insurances, the Rebate Assignment, the Remarketing Agreement, the Standby Loan Agreement, the Owner Guarantee (as such terms are defined in the Lease), the Novation Agreement and any other documents the parties hereto agree should be the Lessee Documents.

All the Company's rights, title and interest, present and future, to and in respect of proceeds arising under:

(A) all Insurances (as defined below) in respect of all risks of physical loss or damage (including, but not limited to, war risks) effected in relation to the Aircraft and all benefits thereof (but for the avoidance of doubt the Assignment of Insurances does not constitute an assignment of any policies of insurance but only of the benefit, rights, title, interest and proceeds thereunder insofar as the same relate to the Aircraft); and

(B) any Requisition Compensation (as defined below) relating to the Aircraft (Provided that, unless and until the Aircraft becomes a Total Loss (as defined below), the assignment of Requisition Compensation contained in the Assignment of Insurances shall be subject to the prior entitlement of the Company under clauses 19.2 and 19.4 of the Lease);

"Insurances" means any and all policies and contracts of insurance required to be effected and maintained under the Lease;

"Requisition Compensation" means all moneys or other compensation from time to time receivable by the Owner, the Company or any other person in respect of the requisition for hire, title, acquisition, capture, deprivation, detention, condemnation, confiscation or seizure of the Aircraft;

"Sub-Lessee" means any person to whom the Company sub-leases, charters, hires or otherwise parts with possession and/or operational control of the Aircraft in accordance with Clause 13 of the Lease;

"Total Loss" in relation to the Aircraft shall mean:

(i) actual or constructive or agreed or arranged total loss thereof; or

(ii) requisition for title, requisition for hire, forfeiture or any compulsory acquisition whatsoever thereof (but in the case of requisition for hire only if the same results in an

insurance settlement on the basis of a total loss) by any governmental or other competent authority or by any person acting by or purporting to act by the authority of the same; or

(iii) as a result of any law, rule, regulation, order, decree or other action by any governmental body having jurisdiction, the use thereof for air transportation of persons having been prohibited for a period of six (6) consecutive months; or

(iv) the theft, expropriation, appropriation, requisition for use, restraint, detention, confiscation, seizure or hi-jacking of the Aircraft which shall have resulted in the loss of possession thereof by the Company or any Sub-Lessee for one hundred and eighty (180) consecutive days or such longer period as the Owner may agree in writing; or

(v) the Aircraft not having been heard of for thirty (30) consecutive days.

- 1 The original instrument (if any) creating or evidencing the charge, together with these prescribed particulars correctly completed must be delivered to the Registrar of Companies within 21 days after the date of creation of the charge (section 395). If the property is situated and the charge was created outside the United Kingdom delivery to the Registrar must be effected within 21 days after the date on which the instrument could in due course of post, and if dispatched with due diligence, have been received in the United Kingdom (section 398). A copy of the instrument creating the charge will be accepted where the property charged is situated and the charge was created outside the United Kingdom (section 398) and in such cases the copy must be verified to be a correct copy either by the company or by the person who has delivered or sent the copy to the Registrar.
