





Absolute assignment by way of security to and in favour of the Assignee of all rights, title and interest (present and future) of the Assignor to and in (1) all policies and contracts in respect of the Insurances, other than Insurances in respect of liabilities to third parties (the "Relevant Insurances"), and (2) all the benefits of such policies and contracts in respect of the Relevant Insurances (including all claims of whatsoever nature thereunder and returns of premiums in respect thereof).
