

"Aircraft" means the one (1) Boeing 757-236 ER aircraft, registration mark G-CPES bearing manufacturer's serial number 29114 together with any or all of the two (2) Rolls-Royce RB211-535E4 aircraft engines bearing the manufacturer's serial numbers 31531 and 31532 respectively, (whether or not any of the engines may from time to time be installed on the Airframe), as described in the Aircraft Lease Agreement with Purchase Option;

"Aircrast Lease Agreement with Purchase Option" means the aircrast lease agreement with purchase option in relation to the Aircrast executed and dated 16 March 1998 and made between (1) the Assignee, as owner, the Assignor, as hirer, as the same may be amended, modified, supplemented or superseded from time to time;

"Engine" or "Engines" means (a) any or all (as the context may require) of the two (2) Rolls-Royce RB211-535E4 engines bearing Engine Serial Numbers 31531 and 31532 originally installed on the Airframe at Delivery, whether or not from time to time thereafter installed on the Airframe or any other airframe and (b) any other engine which may from time to time be installed upon or attached to the Airframe which becomes the property of the Owner in accordance with the Aircraft Lease Agreement with Purchase Option and (c) insofar as the same belong to the Owner, any and all appliances, instruments or accessories or other equipment or Parts of whatever nature from time to time relating to an engine referred to in (a) and (b) above whether or not installed on or attached to such engine and (d) insofar as the same belong to the Owner, all substitutions, replacements or renewals from time to time made on or to any item referred to in (a), (b) and (c) above in accordance with the Lease Agreement with Purchase Option:
