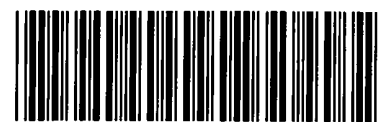



The financial statements are presented in sterling which is the functional currency of the company and rounded to the nearest £.


