### **REPORT OF THE DIRECTORS**

The directors present their report for the year ended 31 March 1995.

#### **STATEMENT OF DIRECTORS' RESPONSIBILITIES**

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### **REVIEW OF ACTIVITIES**

The company is a non-operational corporation as detailed in Note 1 of the accounts.

#### **DIRECTORS AND INTERESTS IN SHARE CAPITAL**
