Restatement of share capital

On 27 June 2016 the directors passed a Special Resolution that the share capital of the company be reduced by £1 by cancelling and extinguishing 100 ordinary shares of £0.01 each (Note 6). This resolution was not recognised in the financial statements of the company for the years ended 30 June 2016 or 30 June 2017. This has been corrected in these financial statements by restating the comparative figures as at 30 June 2017.

Notes to the financial statements for the year ended 30 June 2018

1. General information

CHA (2005) Limited (the 'company') is a private company limited by shares which is incorporated and domiciled in England and Wales. The address of the registered office is: CHA (2005) Limited, Allen Ford – Warwick, Tachbrook Park Drive, Warwick, CV34 6SY. The company is a non-trading entity.

The Company's financial statements are presented in Sterling.

2. Accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless stated otherwise.

2.1. Basis of preparation of financial statements

The financial statements of the company have been prepared in accordance with The Companies Act 2006 as applicable to companies using Financial Reporting Standard 101, "Reduced Disclosure Framework" (FRS 101). The financial statements have been prepared on a going concern basis, under the historic cost convention.

The preparation of financial statements in compliance with FRS 101 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the company's accounting policies.

These Statements have been prepared using all standards and interpretations required for Financial periods beginning 1 July 2017. No new accounting standards, or amendments to accounting standards, or IFRIC interpretations that are effective for the year ended 30 June 2018, have had a material impact on the Company.

2.2. Financial Reporting Standard 101 - reduced disclosure exemptions

The company is a wholly owned subsidiary of Super Group Limited and is included in the consolidated financial statements of Super Group Limited which are publicly available (Note 7). The following exemptions from the requirements of FRS have therefore been applied in the preparation of these financial statements, in accordance with FRS 101:

On 27 June 2016 the directors passed a Special Resolution that the share capital of the company be reduced by £1 by cancelling and extinguishing 100 ordinary shares of £0.01 each.

This resolution was not recognised in the financial statements of the company for the years ended 30 June 2016 or 30 June 2017 in which the number of ordinary shares was incorrectly stated as 10,579.

This error has been corrected in these financial statements by restating the comparative number of shares from 10,579 to 10,479 and reducing share capital as at 30 June 2017 by £1 from £106 to £105.

Amounts owed by group undertakings as at 30 June 2017 have been restated from £106 to £105 accordingly (Note 5).

7. Ultimate parent and controlling party

The immediate parent undertaking is Charles H.Allen Limited, a company incorporated in England and Wales.

The ultimate parent undertaking and controlling party is Super Group Limited, a company incorporated in South Africa, which is the parent undertaking of the smallest and largest group to consolidate these financial statements.
