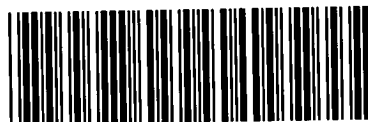

The Company has not traded during the year and the directors do not expect the Company to trade in the forthcoming year.




