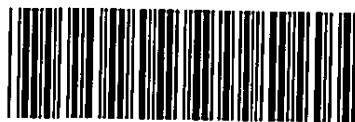


Notes to the Accounts
